5. You are required to maintain your booth/space during the event. No early take downs please.
6. Garbage: All vendors must remove their own garbage from the premises.
7. All vendors are encouraged to forward the weekly notices to their family & friends to help promote the event.
8. All vendors will be given 1 parking spot next to their space. Jodi will discuss with you how the parking will be set up.
